Euralarm represents the fire and security industry, providing leadership and expertise for industry, market, policy makers and standards bodies.

Our Members make society safer and secure through systems and services for fire detection, intrusion detection, access control, video monitoring, alarm transmission and alarm receiving centres. Founded in 1970, Euralarm represents over 5000 companies within the fire safety and security industry valued at 67 billion Euros. Euralarm Members are national associations and individual companies from across Europe.

HOW DOES IT WORK?

Our association is democratic, transparent and open, and its work is based on strengthening representation and awareness of the European fire safety and security industry, allowing it to pursue common interests and to establish framework conditions for a successful and sustainable future.

Other objectives are to ensure the highest level of safety and security for society and to be recognised as experts and trusted advisors in the fire safety and security Industry. We do so while respecting all applicable legislation to the full, in particular competition and antitrust laws, and demonstrate and promote the highest ethical, environmental and sustainability standards.

EURALARM SECTIONS

There are four Sections arranging separate Section Members' Meetings: Sections Extinguishing, Fire, Security and Services.

One Delegate to a Section is nominated by each company or association Members of the Section for a term of three years.

The Chairman and the Vice-Chairman of a Section come from different Euralarm Members and take part in the Board.

Section Member's Meeting decide on their own work programmes, but report to the Board.

TECHNICAL GROUPS

- Euralarm Technical Groups are set within Sections and bring together with invited experts in specific topics relevant to the Sections' activities.
- Some topics covered by Technical Groups are: Market Driven Standardisation, False Alarms, the Construction Product Regulation, Domestic Fire Safety, Standards, Interoperability, Export Strategy and Remote Services.
- Each Task Group is managed by a Coordinator and manages one or more specific task projects.
- Task Group Coordinators report to the relevant Section Chairman.

COMMITTEES

- More oriented towards Euralarm's internal processes than Technical Groups, Committees Include Delegates from each Section, as well as experts on the topics they cover.
- Topic currently covered by Committees are internal and external Marketing and Communications, Advocacy, Finance and Administration and Horizontal Compliance.
- The Committees are coordinated by the Euralarm Board with the support of the General Management.
- The Committees report to the Board via their Chairmen.

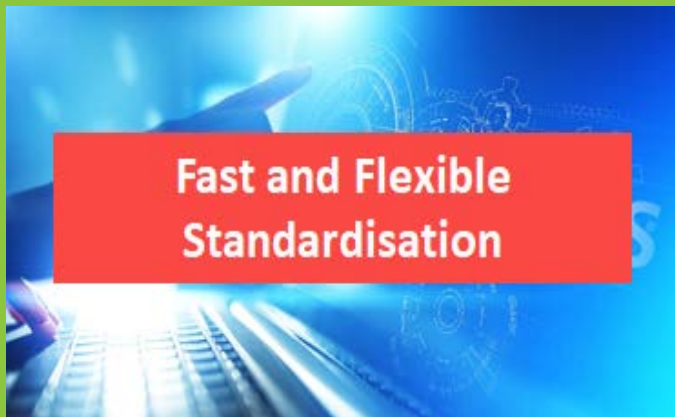
